2. Dr. Badenhoop moved for the approval of the minutes from the August 25, 2017, Faculty Assembly meeting (*Annex 1*). Motion Carried.

3. Dean Ochoa reported the following for Dr. Orlikoff:

- For the standard (not seeking action) file, the narrative should be a self reflection on teaching and self assessment of teaching practices. For those seeking action, the narrative will also need to address service and professional growth and development.
- Tuesday, 10 October, Governor Justice will be holding a Town Hall meeting at 10:30 am in the Davis Conference Center.
- Working on "Student Enrollment and Success Plan" that will be shared soon.
- Recognized April Shapiro, director of the nursing program
- The Nursing Program will undergo its board of review on Friday 13 October
- New Faculty administrative assistant has been hired. Kay Jones will start on Monday, 2 October.
- 4. Mindy Walls, Assistant Vice President of Entrepreneurship and Innovation presented the following
 - Invited all faculty to apply for IDEA Fellows (*Annex 6a and b*)
 - O Program where faculty will infuse ideas of entruprenuership in an already existing course, create a new course, or infuse into a general education course
 - o Looking for true believers in the program, in the application you nee to have
 - Why you want to do it
 - Letters of support
 - o This is a 2 year fellowship and will include a week at Babson College for a workshop.
 - o Applications are due by 12 October and selections will be notified by 15 November
 - o Ideally there will be 2 fellows selected from PSC
 - o \$4000 stipend for the semester that the course is developed
 - Target run semester for the courses is Fall 2018
 - Course must be offered at least twice
 - o Cohort of 5 will meet monthly
 - o Visit http://ideahub.wvu.edu/ to see existing fellows
- 6. Beth Little, Director of Enrollment Services presented the following
 - Thanks to all who help at the Open House Saturday 23 September.
 - Next Open House is Friday, 10 November
 - Enrollment Presentation (Annex 7)
 - o Overall we are down 33 First-Time Freshman
 - o Up with transfers (mainly from WVU, WCM, and Eastern)
 - o Biggest decline area is from the Early Start programs
 - Mainly from Berkley County
 - Shifting demographics mean fewer high school students, thus fewer for the Early Start programs
 - FTE is down only 8
 - o Increase in Academic Preparedness of students
 - Moving forward under the One WVU
 - New viewbook (*Annex 8*)
 - New recruitment opportunities open to us
 - New online application for admissions
 - Very mobile friendly
 - Imported directly into Banner
 - One FAFSA code
 - o Rolling out new social media handle
 - PSC Enrollment, look for it on Facebook, Snap Chat, Instagram, and Twitter
 - New website should be live by mid October

- 8. WVU Senate report by Senators Johnson-Olin, Goff and Wilcox
 - President Gee's State of the University address
 - State suffers from negative-elitism
 We need to change the story start telling what is working
 - Student culture is improving across all campuses a record number 6200 new, first-time freshman have enrolled. They have higher grades, higher tests scores and are better all-around students than previous classes.
 - o Humanities Center has leveraged endowed funds
 - o 8 November is a University wide Day of Giving
 - o New survey will be sent out regarding the culture of the college
 - Biggest Challenge facing the University is not the financial crisis, but complacency and lack of curiosity
 - Cannot cut our way to prosperity
 - o From the Senate Meeting
 - Provost McConnell reported
 - 20,000 people attended Fall Fest
 - Arrests are down, sign of the culture improving
 - Most qualified class ever
 - o Over 50% female
 - Title IX is about educational equity. Will continue to keep the campus safe and not back off Title IX. Remain fully compliant with federal standards
 - Higher Learning Commission (accrediting body) is visiting March 5-6. Need to be ready on all fronts.
 - Since we have separated from HEPC, we need to write HEPC policies to BOG rules
 - Two committees have been set up
 - o CB Wilson addressing faculty rules process
 - o Paul Krieder addressing the academic rules process
 - o Both committees will look for input from faculty
 - Title IV sanctions for failing to file audits.
 - Program approval will face higher scrutiny
 - o Federal Board will need to approve changes to curriculum
 - Heightened cash monitoring process
 - o Reimbursement for financial aid for students
 - Budget was passed on 29 June
 - New \$300 international student fee was approved
 - Will begin after a one year delay
 - \$1.54 bill in revenue, but \$1.66 billion in expenses
 - Voted to increase tuition by 5%
 - Cindy Roth, President of WVU Foundation, reported \$1.125 billion in endowments, but most it earmarked for specific causes
 - 13 October marks the transition from bimonthly pay to biweekly pay

• Expect a reduction of 7 to 7.5% in your paycheck. Your pay will not be reduced, just redistributed over a different number of checks.

- 13. Dr. Ballard called for a vote on "Faculty Workload and Pay Guidelines". (*Annex 2*). Faculty overwhelming approved the document.
- 14. Dr. Ballard called for a vote on "Governance Charter". (*Annex 3*). Faculty overwhelming approved the document.
- 15. "Promotion and Tenure Rubric" (*Annex 4*) will be voted on at the October Faculty Assembly meeting. The input from the Open Forum held 23 September was included in the revised document.
