- Dean Ochoa reported that there are now three levels of suspension/probation. 1.85-1.99 GPA had forty students. These students will have to appeal and can come back in the fall on the academic recovery program. 1.4-1.849 GPA had seventy-one students. These students can appeal and will have to take a summer program online before they can come back in the fall. Below 1.4 GPA there were seventy-six students. These students can appeal and these are only allowed back on a case-by-case basis.
